## Legislative oversight of waived testing is imminent.

- The Department of Health and Human Services (HHS) and The Centers for Medicare and Medicaid Services (CMS) have identified vulnerabilities and quality problems with waived laboratories.
- CMS has initiated a Certificate of Waiver Laboratory Project that includes on-site visits to a limited number of waived labs in all 50 states.
- A Centers for Disease Control (CDC) expert group recently recommended a change to the Clinical Laboratory Improvement Amendments (CLIA) statute that currently exempts waived labs from quality control programs, proficiency testing and inspections.

## The facts speak for themselves:

- More than 30% of labs do not routinely check the product insert or instructions for changes to the information
- More than 30% do not perform Quality Control testing as specified by manufacturers' instructions
- Nearly 50% do not document the name, lot number for tests performed
